



## Guaranteed Start Agreement

6:30 A.M.--6:00 P.M. Monday - Friday

Ages Served: 6 weeks- 12 years

(Non Refundable) paid to hold a spot. Classrooms are by school year. The cut off day is September 2nd for each age.

(\* Agreement will be for specific days. Additional days will be upon request and availability at the higher rate.)

- Full time is 3 or more days per week. Part time is not offered for children in The Burrow or The Hive.
- LATE FEE (After 6:00 PM) & EARLY (before 6:30 AM) will be \$2.00 per minute.
- Fees are due whether child is in attendance or not
- Weeks that contain Holidays will be charged at the regular rate.
- Discounts: 10% sibling discount from oldest child's tuition.

**Fees are due in advance on Monday.** \$25.00 late payment convenience fee added if not paid by Tuesday at 6:30 AM. \$5 maintenance/collection fee for each additional day not paid in full. Failure to pay on time may result in termination of services. \$35.00 fee added on all returned checks. Fees for two weeks will be added if a two week written notice is not given prior to your child leaving. My Childcare Academy may seek collection of fees; clients may be required to pay a two week termination fee, and any collection costs and attorney's fees incurred by My Childcare Academy to collect this amount. If My Childcare Academy elects, it may immediately terminate all services provided by it including but not limited to the immediate dismissal of the children from it's facility.

**Guaranteed Start Agreement:** The deposit in order for you to be given a guaranteed start date consists of a \$80 registration fee and the first and last week's fees (fees through Friday of the first week in attendance and fees equal to one weeks tuition at the current rate to be held for the last week your child(ren) attend or owe fees). You will be responsible for full fees effective that date, whether or not your child is in attendance. In the event you fail to start on your guaranteed start date, your fees will automatically be added bi-weekly. Failure to pay these fees by 6:00 PM of the first Monday after your guaranteed start date, and by 6:00 PM every subsequent Monday, will constitute a forfeiture of your deposit (as explained above) as well as your child's spot in the center. **The deposit is non-refundable.**
